**NH RSA 263:35 Non Resident Who Establishes A Residency In A State**

...any non-resident driver of a motor vehicle who holds a valid driver's license in another jurisdiction, upon the establishment of a bona fide residency in this State, shall have a **maximum of 60 days** from the date his residency was established to obtain a **drivers license issued by the state of New Hampshire.**
