Be it hereby resolved, That we, the residents of the Town of Tilton, County of Belknap, State of New Hampshire, do hereby claim and sustain that the dwelling at 61 School Street, in said town, known as the “House By The Side Of The Road,” formerly owned by Charles G. Forrest, was the residence of Samuel Walter Foss while a student a Tilton School, then known as The Tilton Seminary. That during 1877 or 1878, while residing in the town of Tilton and attending Tilton Seminary, Samuel Walter Foss wrote his now famous poem, the “House By The Side Of The Road” in the house at 61 School Street, in the aforesaid town. That evidence now in the possession of local citizens would substantiate this claim have been investigated and recorded, and that these facts should be presented to the Honorable Ralph Sanborn, Chairman of the New Hampshire Historical Commission, at a hearing being conducted at the request of Wesley Powell, Governor of the State of New Hampshire, to be held March 10, 1960, at the State House in Concord, for their evaluation and adjudication.

Continuation of the 2011 Business Meeting

April 21, 2011

- 1) Moderator Mitchell explained the purpose of this meeting was not to rehash what was said in the past, and hopefully with the new information any misunderstandings will be ironed out. Motion was made that any motion for reconsideration would require a 2/3 majority vote, which passed.
- 2) **Article 3** was read to the assembly. Discussion followed. A vote was taken and since it did not have a 2/3 majority vote, it failed.
- 3) Moderator read Article 4 to the assembly. If Article 3 is adopted, this Article will be tabled. Discussion followed. Motion was made to postpone this Article indefinitely, which failed without a 2/3 vote. Moderator stated that we are now back to the main article.
- 3) **Article 4**, bringing water to Business Park Drive, moved to the floor for discussion. Ken Randall wanted to amend the amount the town would have to bond. The moderator pointed out that this had already been done. Only a majority vote was needed to add the amendment, which passed. Next they were to vote on amended Article 4 and they needed a 2/3 vote to pass this. The motion failed by 3 tenths of a percent. it was moved to reconsider Article 4, and this needed a 3/4 vote, which passed.
- 4) Motion to adjourn was passed and it was determined that the next meeting would be at May 20th at 6 p.m.

Continuation of 2011 Business Meeting

May 20, 2011

- 1) Meeting was called to order by Moderator Chuck Mitchell. He explained how the meeting would be conducted and that the meeting was for reconsideration after the April 21, 2011 Town Meeting.
- 2) Article 4 read by Moderator. If Article 3 is adopted, this Article will be tabled. Article 4 would not require a 2/3 majority in order to pass, all that's necessary would be 50/50 simple majority vote.
- 3) It was suggested that the select board was deceptive with changing to the 50/50 simple majority vote, however since it had become a non-bond article, a 2/3 vote was no longer legally required.
- 4) Katherine Dawson explained how the select board was, in fact, working with the townspeople's interests in mind and explained how they were, in fact, transparent.
- 5) The Moderator instructed that everyone needed to vote on the amendment, because to vote on it had been passed. It needed only 10 votes, and this was not the one hour wait for votes to be counted. 65 were in favor, 78 opposed. Amendment failed.

- 6) Next came the original motion that was presented in April. This would require a 2/3 vote as it was a bond issue and must be open for an hour. The vote was taken, upon ending the debate, and passed.
- 7) Moderator Mitchell said that they were now down to the original article as printed in the town report. It was asked if there were any way they could redo on the vote, because several people were confused on what they were voting for. The Moderator responded if they were to revote on that, it would require a motion for consideration and it would need to be seconded. As he'd established at the beginning of the meeting, it would require a 2/3 vote and would require another town meeting per state statutes.
- 8) The Moderator read the article. The polls were open at 8:12 and were closed at 9:13. 139 ballots were counted, 49 in the affirmative and 90 opposed. The motion to adjourn was made and seconded.

Selectman Boudreau gave a statement of thanks and recognition to Foster Peveryly for his 18 years of service on the Zoning Board of Adjustments, presenting him with a plaque.

Selectman Joe Jesseman gave a report on the state of recycling in Tilton. Selectman Consentino commended the Police Department. Tom Gallant, CHAT co-founder, gave a power point presentation illustrating the accomplishments in rehabbing the Grange Hall into a Senior Center.
